



**Bill S.5898 (Bonacic)/A.8068 (Pretlow)**  
**Constitutional Amendment to Allow Casinos on Non-Indian Lands**  
**New York State Senate, June 21, 2013**

This concurrent resolution purposed to amend the State Constitution to allow the establishment of no more than seven (7) gambling casinos on non-Indian lands. The resolution passed both houses of the State Legislature in 2012. On June 21, 2013, this resolution passed the New York State Senate again by a vote of 55-8. The amendment, known as Proposal One, was approved by New York voters at the ballot box on November 5, 2013.
